Climate change is now an indisputable fact. Average temperatures on the planet have risen by some 0.8°C in the last 100 years. Most scientists believe that the rate of warming will increase further by the end of the 21st century owing to the build-up of greenhouse gases in the atmosphere.

This phenomenon has a direct impact on the Common Agricultural Policy. Even though agriculture produces some of these greenhouse gas emissions (9.3% of the total in 2007 compared to 11% in 1990), the ratio underlines the fact that agriculture can also make an active and positive contribution to efforts to alleviate global warming. This can be done within the framework of a strong CAP serving sustainable and economically viable development.

The report, as amended, takes a comprehensive approach to the relations of the EU with Latin America, by focusing on the relevant priorities for the bi-regional strategic association, such as the promotion and defence of human rights and common values, gender equality, economic integration, fight against economic and social inequality, climate change, etc.

On the contentious point of the EU multi-party trade agreement with Andean Community, a satisfactory compromise was achieved that stressed the need for an adequate parliamentary ratification procedure to address all the issues of mutual concerns, and especially to make sure that human rights, labour rights, social and environmental standards are fully respected in these agreements.

The Conference of Presidents charged JURI with drawing up this initiative report as there was the need for the Parliament to urgently define its position on delegated acts under the Lisbon Treaty. Article 290 of the Treaty, allows the legislator (EP and the Council) to delegate to the Commission the power to adopt non-legislative acts "delegated acts" (Article 290(3)) of general application to supplement or amend certain non-essential elements of a legislative act. The report outlines the principles and specific conditions for controlling the exercise of delegated power.

The Commission presented a White Paper on the strategy to adopt in the European Union to adapt to climate change. The rapporteur supports the Commission proposal and presents a number of recommendations on what should be done in the different policy areas to prepare for climate change. Adaptation and 'climate-proofing' should be mainstreamed in all policy areas.

The resolution calls on the Commission : to make floods and droughts a priority , in terms of planning national civil protection, to focus on adaptation policies in water, soil, fisheries, agriculture, and coastal areas policies. It also calls on the Commission and Member States to do more on adaption in the areas of transport, infrastructure, urban environments, energy, cultural heritage and biodiversity. The Rapporteur considers that adaptation is an opportunity to create new sustainable jobs in Europe.

The modifications of the Structural Funds General Regulation (EC 1083/2006) come as a response to the economic crisis and aim giving faster and easier access to EU structural funding. The rapporteur strongly defended the socialists' position on the need to speed up the flow of EU money to beneficiaries and to simplify the structural funds' implementing rules. "Anti-crisis" measures such as the increased advance payments for countries worst hit by the crisis and more flexible spending rule (decommitment rule) for 2007 funds for all member States are clear demonstration of solidarity. These important measures will enable investments in projects that create jobs and help workers to adapt to economic change. The socialists fully support a quick entering into force of the amended Regulation in order its positive effects to be experienced before the crisis is over.
