### Conclusions of the European Council meeting

We are glad that at least some steps forward were made with the agreement to implement the Single Supervisory Mechanism (SSM) in the course of 2013 – although we deplore the lack of clarity on the timeframe.

The progress made is thanks to French president François Hollande's insistence on swift action. His strong social-democratic voice is making a positive difference in Europe, delivering on the promises made at the June Council Summit.

We strongly support full SSM membership for member states that are not yet part of the eurozone. This new supervision mechanism must ultimately be under the responsibility of the European Central Bank. All steps on this path to a banking union must involve a strong role for the European Parliament.

With more than 25 million people unemployed in Europe today, we must take action for our citizens and provide jobs and a decent standard of living. We urgently call for a more social Europe.

### Consular protection for EU citizens abroad

The file provides the Parliament's view on the proposed directive on 'Consular Protection for Citizens of the Union Abroad', in the context of a consultation procedure.

The work on the file was mostly unproblematic and the main discussions revolved around whether the EU delegation or the lead state (as originally proposed by the European Commission) should co-ordinate consular protection in third countries. Our purpose was to seek to ensure a clear role for EU delegations in third countries and broaden the definition of unrepresented citizens to those who are represented but cannot access their embassy or consulate in normal circumstances.

These functions of European Union delegations include co-ordinating burden sharing and facilitating co-operation between member states' diplomatic and consular services at a local level; co-ordinating emergency planning; the provision of information to unrepresented citizens including through Commission and member state websites, and – where appropriate – allowing the EU delegations themselves to be entrusted with consular tasks.

### Community regime for the control of exports, transfer, brokering and transit of dual-use items

This dossier deals with export authorisations for dual-use goods. These are highly sensitive goods that can be used for both military and civil purposes.

Tight regulation is essential to avoid the misuse of these items and the current legislation can be improved. Therefore several amendments were tabled, mostly with cross-party support from the S&Ds and ALDE, GUE/NGL and the Greens. In particular we looked at a stricter notification process to avoid loopholes. Furthermore, special attention was given to the rise in cybercrime and violations of human rights.

### EU-Russia trade relations following Russia's accession to the World Trade Organisation (WTO)

The EU is one of Russia's strategic trade partners, ranking as its first source of imports, its main export destination and a key investment partner. On the other side, Russia has become the EU's second source of imports (with a value of €158.6 billion) and its fourth destination for exports (€86.1 billion).

This resolution therefore welcomes Russia's admission as a member of the WTO and underlines how it can facilitate trade flows between the EU and Russia, while stimulating economic growth and job creation on both sides. It also underlines the potential for concluding a new partnership and co-operation agreement as a further opportunity to contribute to an enhanced partnership. Another important element outlined is the implementation of the so-called 'common steps towards visa-free travel' as an element of EU-Russia trade and investment relations.

The text does however warn against restrictive measures. These have included a ban on imports of live animals from the EU, legislation favouring domestic producers in public procurement, decisions establishing seasonal import duties and new legislation imposed by Russia concerning a recycling scheme for vehicles.

### Discharge 2012: EU general budget - Council

Inés Ayala Sender, the S&D rapporteur for the budget discharge, has tried to find a constructive way through this thorny issue and to promote open dialogue between the Council and the Parliament over how the Council discharge should be carried out, especially as the previous 'gentleman's agreement' has become obsolete since the Spanish Presidency. In recent years the European Parliament has carried out the discharge procedure separately for each institution or body, based on the fact that the different institutions now implement the separate budget attributed to them in the annual budget procedure. All but the Council have accepted this separate discharge process carried out by the budget committee on behalf of the Parliament, leading to a plenary vote for each body.

Sadly, the Council continues to refuse to co-operate with requests for information from the budget committee. Given this lack of willingness to co-operate – and the unlikelihood of any developments in the next few days – it seems logical for the Parliament to maintain its position and refuse to discharge it again. Although the budget committee voted clearly against granting discharge, it also recognised the need to propose to plenary a specific inter-institutional relationship between the institutions. The text adopted in Committee establishes a solid basis for future progress for the first time.
