The escalating levels of violence in Ukraine over the past few days have to be answered from the EU with determined sanctions, including visa-bans and asset freezes. These sanctions have to be targeted directly at the perpetrators of the violence, not as a symbolic gesture from the EU but as a direct response to the actions of the interior ministry, police and security forces. We continue to support a roadmap to free and fair elections in Ukraine, to ensure the full independence and the integrity of the country.

Single market governance within the European Semester 2014 / Rapporteur

The report focuses on the 'Single market for growth and jobs' report accompanying the Annual Growth Survey, which deals with the state of the integration of the single market and addresses country-specific situations. It stresses the need to improve the governance of the single market by establishing, as a pillar of the EU semester, an annual single market governance cycle that includes: an internal market scoreboard; an annual report on the integration of the single market (as part of the Annual Growth Survey); European Council guidance to member states; national action plans aimed at implementing the single market guidelines; and dedicated country-specific recommendations. This single market pillar should cover a clear set of priorities related to the real economy and key growth areas – the services, energy and transport sectors and the digital single market – and to the measures included in the Single Market Acts I and II.

Following the plenary vote on the Commission proposal as amended in October 2013, the rapporteur sought a mandate to start negotiations with the Council. This request was approved by a vast majority and the report was referred back to the environment committee. A series of informal trilogues were held with a view to agreeing a compromise text. Negotiations were concluded successfully and the outcome is close to Parliament's position voted in October. If Parliament adopts the compromise, this dossier can be concluded in first reading. The main aim of the directive is to deter young people from taking up smoking. Misleading flavours and packages have been banned and rules on E-cigarettes have been established. EU member states have the freedom to go further on packaging if they choose to.

Railway package: safety and interoperability / Shadow

As part of the 4th railway package, the new interoperability directive will reduce the production costs for rail rolling stock and establish a one-stop shop for market authorisations with the aim of reducing the existing 26 national procedures to one single passport. With this proposal we will cut red tape whilst lowering the costs for manufacturers in order to boost railways in Europe and make them more affordable. We also need to maintain the good safety record of railways in the EU, while at the same time reducing the 11,000 existing national rules that block the growth of a true single railway area. Our group has managed to ensure harmonisation will not come at the expense of workers' rights and safety levels. We want a single railway area, but not at any cost – it needs to be safe above all.

Opening of the market for domestic passenger services - PSO regulation / Shadow

This report – part of the 4th Railway Package – deals with the opening up of the market for domestic rail-passenger services. In contrast to the Commission's proposal, the direct award of public service obligation (PSO) by rail could be maintained. The option of a modest market-opening scenario based on the volume of the market has been introduced for EU countries who decide to tender domestic railway services. Small member states would only need to have two different public service contracts, but larger ones would need up to four. In the case of changes between railway operators, the S&D Group managed to include clauses to protect the social standards of employees so that social protection and efficient competition can co-exist. Other issues covered by this revision of the 2007 PSO legislation are clear internal and external reciprocity, a stronger system for in-house awards, new obligations for the relevant authorities such as transport plans and non-discriminatory access to rolling stock for all railway operators.

The S&D Group took the lead regarding the establishment of the new Fund for European aid to the most deprived (FEAD), a new tool to alleviate the most severe forms of poverty, namely food and material deprivation in all EU countries. The S&D Group ensured that the Fund's budget was increased and can only be used to support the most deprived. Furthermore key stakeholders such as food banks, charities and civil society must be consulted and involved in the design, operation and monitoring of national schemes which implement the programme. FEAD is a sign of European solidarity with those hit hardest by the crisis, even though the increased budget is still far from being enough. In 2010 nearly one quarter of Europeans (120 million people) were at risk of poverty and social exclusion. The budget is reserved for the aid to the most deprived and should not be used for other cohesion fund activities. FEAD is only a complement to national policies; the responsibility and obligation to combat and eliminate poverty remains with member states.

The eCall scheme is an EU-wide inter-operable emergency call system, with a device embedded in the vehicle which can connect to the 112 emergency number. This device will automatically alert the rescue services to road crashes through the public 112 emergency call system and it could save lives and reduce injuries by speeding up the arrival of the emergency services. To complete the implementation of the eCall strategy, it is crucial that EU countries upgrade their Public Safety Answering Point (PSAP) infrastructure to allow eCalls to be properly handled.
