## UK withdrawal from the EU

We welcome the EU leaders' decision to grant a longer extension. # Protection of persons reporting on breaches of Union law

From exposing dodgy tax deals between governments and multinational companies to showing how political campaigns manipulated voters using data driven profiling, whistleblowers have played a vital role in holding the powerful to account in recent years. However, far too often they have faced criminal prosecution and serious professional consequences for doing the right thing. Next week for the first time we will back laws to ensure that whistleblowers are protected wherever they are in the EU. We fought so that whistleblowers will be able to decide whether they report wrongdoing through internal channels or directly to an external body. This was a vital point for us as clearly in many circumstances it is not appropriate for a whistleblower to report wrongdoing within their own organisation."

# Transparent and predictable working conditions in the EU

We S&Ds have fought tooth and nail for these new rules that will improve working conditions and set new rights for millions of workers across the EU, especially the ones on the most precarious short-term or on-demand contracts and workers of platform economy. From now on, workers on these on-demand style contracts will have to be compensated whenever an employer cancels work at the last minute. Companies will be allowed to ask people to work within flexible jobs only within a predetermined set of hours and will have to give workers enough notice when giving them new shifts. Member states will also have to take action against abusive training practices - such as companies who force workers to pay for their own training.

## European system of financial supervision

We promoted a reinforced role of the European Supervisory Authorities (ESAs) in shaping safe financial markets and a consistent approach by the EU on anti-money laundering with a real coordination role for the European Banking Authority (EBA). To do this, we had to improve their governance by giving the ESAs' chairpersons more leeway while ensuring that they are selected through a democratic appointment process, under strict principles including an assessment based on a gender balanced list of candidates. We made significant progress in adding Environmental, Social and Governance (ESG) factors in the mandate of the ESAs, as well as in protection of consumers and whistle-blowers. Good news also in the area of consumer protection, where we provided all the ESAs with a regime to prohibit toxic financial products and, in the field of insurance, the setting up of platforms to combat misselling.
