Introduction

To conclude its first project cycle, the Independent Commission for Sustainable Equality (ICSE) published a first policy report in November 2018. The report issued 110 policy recommendations aimed at breaking ground on developing a progressive, transformative policy agenda responding to the economic, social and environmental challenges and emergencies that Europe, and humanity, are faced with today.

Building on this first report and in close cooperation with the wider political family of European Social Democracy, the S&D Group has been able to successfully integrate a large number of these proposals into the European Union policy agenda. This success was largely achieved by building the ICSE's policy recommendations into its negotiating position in the inter-institutional negotiations on future EU policy following the 2019 European elections.

This analysis provides an overview of the impact the work of the ICSE has had on the output of the European Commission. Of the ICSE's 110 policy recommendations, **60 have been incorporated into the European Commission's policy agenda, at least partially. This represents an adoption rate of around 55%**. Of the five substantive policy chapters in which the ICSE's recommendations were developed, only one chapter saw an adoption rate of less than 50%:

The overview is based on an analysis of the European Commission's political priorities, formulated by the President of the European Commission to seek support for her confirmation by the European Parliament, as well as on the policy documents adopted and published by the Commission since taking office in December 2019. These documents can be understood as parts of a sequential process. Following a political commitment by the European Commission to issue proposals on a specific subject, for instance as part of the Commission President's political priorities, the specialised Commission services develop a detailed strategy for related policy by issuing an official European Commission Communication. Subsequently, the Commission services begin drafting the concrete policy measures, for instance in the form of legislative proposals.

Bearing this in mind, the following overview contains information regarding the stage the different policy processes are currently at. Given that the current European Commission took office in December 2019 and has since been heavily occupied with the development of unforeseen measures to tackle the COVID-19 pandemic, most of the files covered in this analysis remain at an early stage of the policy process for the time being.


When the Commission issues legislative proposals, the European Council, together with the European Parliament for most policy fields, works to amend and adopt the Commission's proposals. This process may lead to substantial modifications of the European Commission's initial proposals and may also lead to their rejection. Until the final adoption of a legislative act, this analysis is therefore aiming at a moving target. The Progressive Society team will therefore continue to update and amend this analysis at regular intervals.



Power to the people



As part of chapter three of its first policy report, the ICSE issued 15 recommendations aimed at stimulating processes of democratic participation in public policy and governance, as well as in the economy. Since the publication of the report, the European Commission has announced policy proposals that incorporate two of these recommendations, at least partially.




Reshaping Capitalism



As part of chapter four of its first policy report, the ICSE issued 43 policy recommendations aimed at transforming the EU economy into an economic model that fosters sustainable wellbeing for all. The recommendations aimed to prevent instability and crises, and tackle the concentration of power in the hands of the few and various forms of exploitation affecting people and the environment. Since the publication of the report, the European Commission has announced policy proposals that incorporate 24 of these recommendations, at least partially. Another two ICSE recommendations are covered by legislative proposals issued by the previous European Commission on which negotiations are ongoing but currently blocked. The current Commission has stated its intention to work to unblock these negotiations. In total, the Commission is thus taking action on 26 of the 43 recommendations included in this chapter.



Social Justice



As part of chapter five of its first policy report, the ICSE issued 33 policy recommendations aimed at mitigating and reversing social inequalities through: poverty alleviation measures; labour market policies to improve the quality of employment and stimulate wage increases; action to fight gender-based discrimination; and instruments to fight territorial inequalities. Since the publication of the policy report, the European Commission has announced policy proposals that incorporate 18 of these recommendations, at least partially.


