Abroad consensus was reached in the Constitutional affairs committee (AFCO). By accession to the European Convention for Human Rights (ECHR), the Union will be joining one of the world's most advanced regional Human Rights' protection systems. As such, the Union's system for the protection of fundamen-Ramon Atondo tal rights will be supplemented and enhanced by the incorporation of the Charter of Fundamental Rights into its primary law, its accession to the ECHR will send a strong signal concerning the coherence between the Union and 'wider Europe', constituted by the Council of Europe and its pan-European human rights system; this accession will also enhance the credibility of the Union in the eyes of third countries.

This report identifies new challenges related to the 'New Skills for New Jobs initiative and proposes a series of measures designed to make renewed progress in this field.

The rapporteur acknowledges that progress has been made in these areas in the member states but notes that more has to be done. High quality education from early childhood is very important for the early acquisition of key competences.

Especially important is to reinforce attitudes towards further learning, critical thinking and creativity. Transversal key competences such as digital competence, a sense of initiative, entrepreneurship and cultural awareness, as well as the opportunity to learn and communicate in foreign languages are all very important aspects.

The Commission needs to put things right rapidly and deliver in the implementation of the Schengen Information System (SIS II), while fully involving the EP at all stages. This delay of three years is unacceptable; security and free movement in the Schengen area are dependent on the SIS II and cannot be compromised by inadequate management of implementation or lack of political will.

In the amendments tabled, we support: 1. the need for the EP to be consulted beforehand for approval 2. any new solution to be cost effective, technologically sound, data protection-proof, feasible in a timely calendar and legally sound, 3. the idea that national experts from member states be included again in the management board of the project, as we believe their absence is one of the reasons for the problems encountered.
