## 2010 progress report on Croatia

The main message of this report is that Croatia can conclude accession negotiations in the first half of 2011, "provided that the necessary reforms continue to be pursued resolutely". Zagreb now needs to mobilise all efforts at this last stage to strengthen public administration and the judiciary, step up the fight against corruption, ensure full cooperation with the International Criminal Tribunal for the former Yugoslavia (ICTY), continue the privatisation process and adopt restructuring plans for the country's shipyards in difficulty.

The report also welcomes the entry into force of the border arbitration agreement between Croatia and Slovenia last year and calls for progress in the resolution of other bilateral disputes, such as the border issues with Serbia, Montenegro and Bosnia-Herzegovina.

The Group recalls that the EU 2020 strategy and cohesion policy are fundamentally linked and that the need to appropriately fund the flagship initiatives should not result in less resources for cohesion policy.

## Rights of passengers in bus and coach transport

The Council's approach that the Regulation should apply only to passengers using buses or coaches for a distance over 500 km is for the Parliament unacceptable as it would have excluded a considerable number of bus connections and even whole Member States territories. The Regulation shall apply to all regular bus or coach services of a scheduled distance longer than 250 km. In the event of an accident or a cancelled or a delayed departure for more than two hours passengers shall have the right, if necessary, to hotel accommodation for a total cost of EUR 80 and for a maximum of two nights.
