The agreement between the Council and the European Parliament sets very ambitious goals for member states and it is a change in the European approach to recycling. We succeeded in getting a directive with a wide scope, so that it applies to all kinds of electric and electronic equipment, including solar panels. We also improved the categories for collecting material, in particular we added a new category for small IT and telephone equipment so that some rare earth materials used for smartphones and other devices can be recycled more effectively.

The institutions agreed on a compromise package, which reconciles environmental and health concerns with innovation and research and with the needs of internal market. The new biocide regulation will: facilitate enterprises marketing their products across the EU by introducing union-wide authorisations for products, bring in strict criteria to ensure that substances hazardous to the environment or human health are not authorized, introduce labelling requirements for many articles treated with biocides. From within the EU budget. Otherwise the future of this programme is seriously at risk. Regarding the relations between European Union and European Space Agency, the S&D Group asks for clear task-sharing and a strong political role for the Commission.

This report is the Parliament's reaction to the Commission communication 'Towards a space strategy for the European Union that benefits its citizens'. It points out that further implementation is needed on the EU's flagship programmes for satellite navigation and earth monitoring, Galileo/EGNOS and GMES (Global Monitoring for Environment and Security). The EU has to develop a common vision and a long-term strategic plan for space exploration. In order to strengthen European competitiveness, adequate investment in research and development is crucial and at the same time international co-operation needs to be strengthened. The Parliament strongly supports the space strategy but urges the Commission to ensure the financing of the GMES programme comes



Memorandum of Cooperation between the European Union and the International Civil Aviation Organisation

The overall goal of the Memorandum of Cooperation (MOC) is to ensure greater harmonisation of standards and closer coordination of the parties' respective activities as well as a better use of resources by avoiding duplication of effort. Cooperation will also include sharing of confidential data and the participation of EU observers in ICAO audit missions. Relevant provisions for actions in the field of aviation safety and security, traffic management and environmental protection are integral part of the MOC. The main body for the implementation of the MOC is a Joint Committee. The Rapport underlined the importance of the MOC in view of a strengthened cooperation in the above mentioned four areas of ICAO activities in which the EU takes a strong interest, not least for the competitiveness of its own civil aviation industry.
