**Commission's Investment Plan**

The S&D Group president Gianni Pittella will react to the investment plan that the European Commission will present on Wednesday. The S&D Group have laid down their proposals and targets. S&D Euro MPs proposed to set up a new €400 billion fund as part of an investment plan to boost growth and create jobs in Europe. We want a shock therapy to be put forward. A shock therapy carried out by new fresh money - public and private - to be invested, a new European investment instrument to be created and finally the adoption of the 'investment clause' associated to Juncker's investment plan: public money put in place by member states for selected European projects should not be calculated in the national deficit. Investments should be targeted towards energy transition and energy efficiency, towards the digital economy and innovation and towards human capital, thus boosting job creation. Europe should focus on projects which could never flourish without a share of public investment.

#### Lampedusa: situation in the Mediterranean and the need for a holistic EU approach to migration

More than one year after Lampedusa, the situation for migrants in the Mediterranean has still not improved. In the first nine months of this year alone, at least 3072 people died crossing the Mediterranean Sea. We can only deal with the complex challenges of migration through a holistic approach. The Socialists and Democrats are calling for more solidarity, a fair distribution of responsibility between member states, more safe and legal avenues for migrants to reach Europe and the development of a comprehensive framework for legal migration. We need to improve the EU's common resettlement policy and encourage more member states to participate, while ensuring that migrants' rights are always respected when the EU co-operates with third countries, especially conflict zones. Hopefully, the Commission and Council will present an ambitious European vision for the future of EU migration and asylum policy, providing an adequate and humane response to the current challenges.

## 2014 UN Climate Change Conference - COP 20 in Lima

This year's Climate Change Conference in Lima needs to set out the main elements of the 2015 global climate agreement which shall include commitments to fight climate change by all countries in order to stay within the "below 2°C" objective. The S&Ds call on industrialised countries to lead by example and present ambitious emission cuts by March 2015 and to provide financial support to help the developing countries achieve their own emission reductions. It is, therefore, crucial to provide clarity on how to scale up the mobilisation of climate finance in order to achieve the joint goal of USD 100 billion per year by 2020 - a goal which has already been agreed on in Copenhagen.



# Combating violence against women – Oral Question

Men's violence against women is a structural violation of women's human rights. Counting all forms of male violence against women, 45% of all women in Europe have been subject to and suffered from men's violence. It is estimated that the total cost of domestic violence within the 27 member states could be as high as 16 billion Euros. Violence against women has a huge impact on victims and also imposes a significant cost on society. While the EU is tackling the problem in many ways, there is no legally binding instrument designed specifically to protect women against violence. We demand an European year to fight against violence against women, the ratification of the Istanbul protocol by the MS and the EU as Commissioner Jourova committed herself to, a framework directive with a real strategy on combating violence against women, a new legal act on prevention measures, a revised proposal for a Regulation on European statistics on gender based violence, and the establishment of an European Observatory on Violence against women.

We believe that the only way to solve the conflict between Israel and Palestine is through the two-state solution based on the 1967 borders, with Jerusalem the capital of both states. In this way, the State of Israel could live in peace and security alongside an independent, democratic and viable State of Palestine. We therefore urge the EU and its member states to play a more active role to this end.
